



# Recreational Activity Waiver

This is a Liability Waiver/ participant Agreement limit the liability of the Irvine Ranch Outdoor Education Center, (IROEC)

PLEASE READ CAREFULLY

### Shooting Sports (Archery, BB Gun)

Injuries and accidents can be near eliminated when safety rules are followed. Participants will show clear knowledge of the safety rules and procedures prior to using any IROEC Shooting Sports equipment. Participants will be taught proper form, safety rules and general knowledge of the equipment. Participants will be expected to adhere to all safety rules and follow guidelines on the care of equipment. Anyone ignoring or not the following expectations maybe sidelined from the activity until sufficient retraining has occurred to ensure everyone's safety. Participants under 8 must be accompanied by and adult 1 on 1 at all times. Absolutely no personal shooting sports equipment is to be brought from home. Personal shooting sports equipment including but not limited to BB guns, Air-Rifle, Airsoft Weapons, bows, arrows, armguards, sight or release may not be brought by participants.



*\* California Penal Code Section 12552: Every person who furnishes any BB device to any minor, without the express or implied permission of the parent or legal guardian of the minor, is guilty of a misdemeanor*

### Adventure Hill (Zip Lines, Challenge Courses, Climbing & High Ropes Area)

Adventure Hill activities offered at the Irvine Ranch Outdoor Education Center involve a certain degree of risk that could result in injury or fatality. All participants shall be provided with and instructed in the proper use of helmet, harnesses, belay equipment and other items required to complete each specific challenge area safely. Participants will be taught proper form, safety rules and general knowledge of the equipment. All participants will be expected to adhere to all safety rules and follow guidelines for proper care of equipment. All participants MUST follow the instruction of the of IROEC staff at all times. Anyone not adhering or following activity expectation may be sidelined from the activity until sufficient retraining has occurred to insure safety. Absolutely no personal climbing equipment or gear may be brought or worn by participants this includes helmets, ropes, carabiners, hardware for climbing, or chalk. Climbing shoes may be worn after inspection by adventure hill Director or designated authority.



**Weight Restrictions: Zip Line and High Ropes Course-** Participants must weigh between 50 lbs. and 275 lbs. **Climbing Tower-** Participants must weigh between 30 lbs. and 275 lbs.

**Age Restrictions: Zip-Line & Climbing-** At least 5 years of age. **Low Ropes-** At least 8 years of age. **High Ropes-** At least 12 years of age.

Participants must be able to fit into all required safety equipment properly regardless of weight or age.

**FOR ALL SHOOTING SPORTS AND ADVENTURE HILL ACTIVITIES STURDY CLOSED TOED SHOES ARE REQUIRED**

### Aquatics (Swimming, Water Sports, Water Slide)

All participants will be expected to adhere to all safety rules and follow instructions of the IROEC Aquatic Staff and Lifeguards. Anyone not following expectation may be sidelined from the activity until sufficient retraining have occurred to insure everyone's safety. No PFDs on the waterslide. Flotation devices or inflatable mats are not permitted in the pool. We do not allow swim diapers. Participants must be 48 inches tall to use the water slide. An adult must accompany children 5 years and under, one-on-one in the water at all times.



### Other Activities

Other available activities at the IROEC include but are not limited to: Mine Immersion, Wacky Science Immersion, Lawn Games, Team Building Games, Breakout Box, Ranch Immersion.

### All Activities

All activities and programs at the IROEC follow the standards of the American Camp Association (ACA), American Red Cross, or Association of Challenge Course Technologies (ACCT).

In consideration of the benefits to be derived and after carefully considering the risk involved and in view of the fact that the Boy Scouts of America is an organization in which participation is voluntary, and having full confidence that precautions will be taken to ensure the safety and well-being of myself (and any minor children for whom I have the capacity to contract), I have carefully considered the risk involved and have given the participant identified below, my consent to participate in the Recreational Activities available at The Irvine Ranch Outdoor Education Center\* (IROEC).

In consideration of accepting this registration, and to the extent permitted by law, I hereby agree to release, indemnify, defend and hold harmless on behalf of myself (and any minor children for whom I have the capacity to contract), the IROEC, the Boy Scouts of America, Orange County Council, program staff, activity coordinators, all employees, volunteers, or other organizations associated with IROEC from and against any and all liabilities, claims, penalties, losses, or expenses (including attorneys' fees), of any kind or nature whatsoever, whether related to bodily injury, property damage or any other form of injury or loss to myself (and to any minor children for whom I have the capacity to contract), caused by any negligent act or omission of the IROEC or its officers, clients, agents or employees, arising out of or in any way related to participation in the activity for which I (and any minor children for whom I have the capacity to contract) am registering.

In case of emergency, I hereby give my permission to the physician selected by the IROEC, to secure proper treatment, including hospitalization, anesthesia, surgery, or injections of medication for myself or any minor children for whom I have the capacity to contract.
